A RESOLUTION OF THE BOARD OF TRUSTEES OF THE NORTH TOOEELE FIRE PROTECTION SERVICE DISTRICT ADOPTING THE 2024 TAX RATE AND INCREASING THE PROPERTY TAX REVENUE BUDGET AMOUNTS




